# SFWMD to Decide in Ft. Myers



At its Governing Board meeting on Nov 9 and 10 in Ft. Myers, SFWMD will decide whether to approve or deny the Conservancy of SW FL petition that SFWMD establish a reservation of 450 cfs rather than an MFL of 300 cfs for the Caloosahatchee estuary. [Naples Daily News]

# **CRCA Board Meeting**




