# Community Activism is Alive and Well

Last fall, a group of neighbors from Waterway Estates in North Fort Myers got together to discuss the state of their canals. They were especially concerned about the trash, grass clippings, palm fronds and oil film in the water. The group's consensus was that because of inadequate education and a lack of motivation, the residents of the area were causing a serious decline in the quality of water in the canals.

The group, calling themselves the *Do Not Feed the Canals Committee*, decided to create an educational program using "Keep It Clean: A Citizen's Guide to Protecting Our Estuary" as a guide. This booklet was produced in 1992 through grant funding and was written by Carla Kappmeyer from the Charlotte Harbor Aquatic Buffer Preserve.

A total of 305 households, the El Rio Golf Course and Calusa Isle Marina have pledged to honor the following practices:

- \* Do not throw yard debris, grass cuttings, citrus or any other foreign matter into the canals
- \* Cut down on the use of fertilizers and pesticides on lawns and trees
- \* Keep sewer drains and street gutters free of dirt and vegetation
- \* Maintain boat engines to avoid oil leaks
- \* Read the "Keep It Clean" booklet

The group has recruited Shuckers Restaurant and the Buttonwood Harbor subdivision to assist with canal clean ups. In addition, they have distributed the "Keep It Clean" booklet to the commercial landscapers who work in the area. ## Manatee Protection

#### It was not a good year for manatees, or was it?

You probably are aware that more manatees died in 1996 than in any previous year on record. That trend was true for the State, the region, and the Caloosahatchee River. Scientists who work with manatees on a regular basis now believe that the tremendous die off last spring was the result of chronic exposure to red tide toxin. Events such as red tide and cold weather are not presently within our control, however, a record number of manatees were also killed within Lee Control by collisions with boats. While collisions with boats may never be completely preventable, many people, including the Florida Department of Environmental Protection, believe that they can be minimized. In an effort to do just that, FDEP has begun the process of developing boat speed restrictions for extensive areas of Lee County. This may be a long and difficult undertaking. It was attempted in 1994 and ultimately was defeated in court. The basic reason that the previous attempt failed was because the FDEP failed to show that they considered all of the impacts in a systematic and objective process.

Part of that process is you! The FDEP significant invests resources in tracking and monitoring They try to. manatee activity. understand the animals in order to understand what they need to survive. It is more difficult for them to understand the human portion of the equation. The FDEP cannot legally cause "undue interference" on the citizens of Lee County in order to protect the manatees that live here. The only way they can understand what the impacts are to boaters, anglers, and waterfront residents (people like you) is for you to become part of the process. The FDEP will be working toward a public hearing in Lee County sometime this Spring. It is up to us to help find the middle ground. There is room for manatees and humans on our waterways. The question is, are we willing to look for it?


The manatee has been in Florida for 45 million years. Some

believe that its days are almost over. The manatee is an indication of the health of our estuaries. What we do in the name of manatee protection can ultimately impact our lives directly. It is time for all of us to consider the future m, we would like for our rivers and coastal waters, and the manatees. And then we need to decide what we are willing to sacrifice. Is it 20 minutes of our boating day or maybe taking the time to pick up tangled fishing line? Is that something we are willing to do to make our future better?

Last year was the worst on record for manatee deaths, but this January, more manatees were counted on the west coast of Florida than ever before. Nature is resilient - to a point. Make your decision and make your opinion part of the process to help make a better future a reality.



#### Oxbow Research Wins Award

Congratulations to Miss Heather Townsend of LaBelle High School for her award-winning science fair project investigating changes in the Caloosahatchee oxbows. Heather's project was selected from among all regional science fair environmental entries to receive the senior division "Senator's Choice Award" from Senator Tom Rossin. Also attending the Senate Council 35 luncheon where Heather received her award were Florida Department of Environmental Protection Secretary Virginia Wetherell, Senator Fred Dudley, Ft. Myers Mayor Bruce Grady, and many other regional dignitaries.

The oxbows are the only remaining sections of the original Caloosahatchee River which to survived the dredging and creation of the current C-43 (Caloosahatchee) waterway. In addition to their historical and aesthetic value, the oxbows are important have.

Caloosahatchee fish and wildlife. Heather's science fair project combined data collected by Riverwatch and University of Florida teams on 18 oxbows with data she personally collected from 15 oxbows. With scientific guidance from Dr. John Capece of UF/IFAS and Mrs. Susan Cooper of LaBelle High School, Heather performed a statistical comparison of these recent data with data from a 1978 SFWMD report and found evidence of changes in the oxbows. While many individual oxbows showed evidence of degradation due to sediment accumulation in the channel bottoms, there was not a statistically significant pattern of sedimentation across all oxbows. However, Heather did find that the measured changes in the oxbow channel widths were statistically significant across the full set of oxbows. These results are evidence of an on-going bank erosion process. Heather's findings will help point the way towards future investigations of the oxbows and projects to protect this important part of our river.
