River Commission Conclusion

The Caloosahatchee- St. Lucie Rivers Corridor Advisory Committee was formed by the Florida Legislature to make recommendations for solving the water quality problems.

The collective expertise in resource management can provide valuable insight to the operation and management of Lake Okeechobee.

The estuarine environment is extremely sensitive to large freshwater releases from Lake O. Scientists focus on analyzing the effects of freshwater discharges on salinity levels, seagrasses, oyster beds and other organisms living within these habitats.
